OUR MISSION

Aid in Difficulty (AID) was founded in 2017 as a nonprofit organization, exempt from taxes under 501 (c) (3).

Our main mission is to glorify God and expand His Kingdom:

«...whatever you do, do it all for the glory of God.» (1 Corinthians 10:31)

AID strives to be a trustworthy and effective channel for churches and individuals to serve the physical and spiritual needs of people worldwide.

This responds to the call:

«...do good to all people, especially to those who belong to the family of believers.» (Galatians 6:10)

Our goal is to connect those who want to help with those in need.

MAIN GOALS OF AID IN PROVIDING ASSISTANCE:

- To help and encourage God's people
- To bring the Gospel to a perishing world

OUR ACTIVITIES

Thanks to the generous hearts and hands of our volunteers:

- WE PROVIDE food, clothing, medicine, and agricultural supplies to orphans, widows, the elderly, and families in need.
- WE OFFER financial support to those in need and help them achieve self-sufficiency by assisting in the creation of their own sources of income.
- WE PRINT AND DISTRIBUTE Bibles and Christian literature among both believers and non-believers.
- WE ASSIST victims of war and natural disasters, as well as those struggling to meet their basic nutritional needs.

OUR CORE FOCUS

...the **LEVITE**, the **FOREIGNER**, the **FATHERLESS**, and the **WIDOW**,.. may eat and be satisfied, so that the Lord your God may bless you in all the work of your hands that you do.

(Deuteronomy 14:29).

The Aid in Difficulty ministry is aimed at four biblical categories of the needy: widows, orphans, foreigners, and Levites. To help people from these four categories of the needy, we use 12 main support programs for the physical and spiritual needs of people.

In the Aid in Difficulty ministry, we see ourselves as a «channel» or «bridge» between those in need and those who wish to help. We strive to provide information about the needs of people and ensure sponsors ways to help them.

WIDOW

At all times, widows and abandoned wives have been socially unprotected people. We also include elderly people in the category of widows, who, due to various circumstances, are left without means of subsistence.

STRANGER

Life can present various emergency circumstances: someone suffered from a fire, flood, and other natural disasters; and someone found themselves in a war zone. In the category of «stranger,» we also include people who have found themselves in critical life situations (economic problems).

ORPHAN

In the countries where we helping are many orphans. Many orphanages are visited by believers with the aim of paying attention to disadvantaged children and bringing a little joy into their lives by distributing gifts and Christian literature.

LEVITES

Preaching the Gospel, instruction in faith makes people able to please God and do His will. People engaged in this spiritual work, we refer to the category of «Levite.» Supporting them is not only charity but also participation in their ministry. Also, assistance to various events related to evangelization.





III. Our 12 Programs

DOMESTIC ANIMALS

Help widows and low-income families buy domestic animals and feed so that they can raise them over the summer period and thus provide themselves with meat.







FOOD PARCELS

Purchase of necessary food products for widows and those in need.



CHILDREN SHOES AND CLOTHING

Help widows and low-income families purchase shoes and clothing for children.

POTATOES

Financial assistance for the purchase of potatoes for the winter period.







WARMTH IN THE HOME

Financial assistance for purchasing fuel during the winter time.







FUNERALS

One-time assistance following the death of a parent.

HOUSEHOLD ITEMS

Material assistance to widows and low-income families in purchasing necessary household items.





HELPING ORPHANS

Visiting orphanages for the purpose of sharing the Gospel and distributing gifts. Providing support to family-style orphanages.







MEDICAL EXPENSES

Financial assistance for medical expenses.



FEEDING THE NEEDY

Twice a week, meals are provided to people along with the preaching of the Gospel.



NATURAL DISASTERS

For families affected by fires, floods, wars, and other disasters.

EVANGELISM EVENTS

Support for missionary families and other expenses related to evangelism.



MINISTRY AMONG PEOPLE WITH DISABILITIES

Missionary work among people with disabilities (those who use wheelchairs, the blind, and the deaf). Single Mothers and Parents of Large Families


Regular Bible studies are held with them, and they are provided with assistance in the form of food packages.



Independent Auditor's Report

To the Board of Directors
Aid in Difficulty Christian International Ministry
Vancouver, Washington

Opinion

We have audited the financial statements of Aid in Difficulty Christian International Ministry, which comprise the statement of financial position as of December 31, 2024, and the related statements of activities, functional expenses, and cash flows for the year then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of Aid in Difficulty Christian International Ministry as of December 31, 2024, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Aid in Difficulty Christian International Ministry and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Aid in Difficulty Christian International Ministry's ability to continue as a going concern for one year after the date that the financial statements are issued or when applicable, one year after the date that the financial statements are available to be issued.



Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due
 to fraud or error, and design and perform audit procedures responsive to those risks. Such
 procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Aid in Difficulty Christian International Ministry's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Aid in Difficulty Christian International Ministry's ability to continue as going the audit.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control — related matters that we identified during the audit.

Report on Summarized Comparative Information

We have previously audited Aid in Difficulty Christian International Ministry's December 31, 2023, financial statements and we expressed an unmodified audit opinion on those audited financial statements in our report dated April 23, 2024. In our opinion, the summarized comparative information presented herein as of and for the year ended December 31, 2023, is consistent in all material respects, with the audited financial statements from which it has been derived.
